Mission/Ministry Statement

The Virginia Churches in Community believes that we are called by God through Christ to be one. We commit ourselves to manifesting more fully this unity in relationship and in action.

Relating to one another in Christ, we will respect one another, rely on one another, care for one another, listen and learn together in order to discern the will of God, support one another's identity and call, and, as we petition in the Lord's Prayer, forgive one another.

Acting together in Christ, we will gather in prayer and council, cooperate in ministry, and, whenever possible, speak to significant issues.

WE WILL work cooperatively and interdependently, respecting one another's traditions and learning how to care for one another.

Goal 2:

Objective 2: Increase the depth of participation of churches currently included in Virginia Council of Churches.
Objective 3: Invite participation from churches not now included in Virginia

Objective 4: Establish a strong ecumenical education component.

Objective 5: Facilitate/support local expressions of ecumenism.

Objective 6: Facilitate/support interfaith conversation, dialogue and cooperation.

Goal 3:

Objective 1: Engage in intentional processes to address racism among ourselves and the churches we represent.

Objective 2: Connect to and/or develop statewide anti-racism education and action programs.

Objective 3: Encourage cooperation among the racial/social justice commissions of Virginia's churches and faith groups.

Objective 4: Bear witness together against the sin of racism.

Goal 4:

WE WILL have an organization and staff adequate to carry out the above-named goals and be sufficiently funded.
